The Fort Scott Area Community Foundation is excited to announce that grants will be available for the upcoming 2019/20 cycle.

Thanks to the generosity of all who have contributed and continue to donate to the FSACF General Fund, the interest accrued will allow the grant committee more opportunities to benefit the 501c3 applicants who meet the qualifications.

Beginning August 1st, the grant application will be available on the FSACF website www.fsacf.com or may be picked up in person at the Chamber of Commerce, 231 E. Wall St. Completed applications will be accepted through the month of August.

Monies granted to the 15 beneficiaries from last year's cycle were used for a variety of causes, providing benefits to:

- educational programs including USD 234, FSCC, and the Lowell Milken Center;*
- new instruments for the FSHS band*
- the needs of cancer patients through Care to Share*
- 2 wheelchairs for Tri-Valley Developmental Services*

Community Foundation Partners with 1st Graders



In August of 2018, the 1st grade team at Winfield Scott Elementary had an idea. They wanted to engage students more fully in their community as a part of their social studies curriculum.

A grant from the Fort Scott Area Community Foundation helped fuel that idea. From December until May, students experienced a variety of community activities such as: Anderson Elk Ranch, The Gordon Parks Museum, Twister Trailer, a game at LaRoche Stadium, an historic trolley tour, Fort Scott Livestock Market and tours of the Post Office.

Not only did students visit businesses and organizations in the community, but they also wrote about what they did at each stop and kept a giant map of the city marking each visit.

Endowed fund balances* as of May 15, 2019:

*Board Controlled General Fund: \$793,100.38
Donor Advised/Controlled Funds: \$7,521,622.28*

Total funds: \$8,314,722.66

****Board Controlled funds** are funds when donated from the general public, memorials, or trusts are not designated to benefit a certain organization, scholarship, or purpose. These are the funds that the Board is able to grant interest from annually.*

****Donor-Advised/Controlled funds** are funds established by donors or trusts to benefit specific organizations, scholarships, or purposes. The interest from these funds is distributed annually among those particular beneficiaries.*

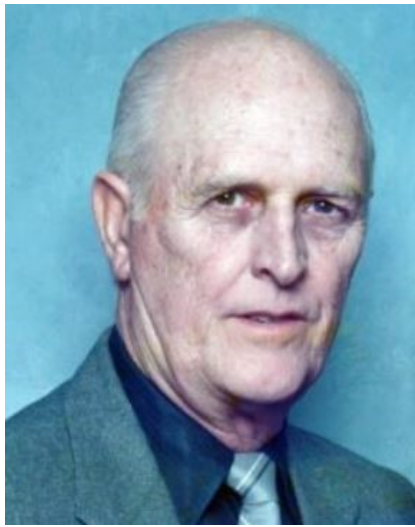
Grant Funds were approved for the following scholarship awards:

Grant Funds were also approved from the Robert and Faye Steele Trust, totaling \$137,131.00.

Bob and Faye Steel were married in 1974. Both were employed at Western Insurance Company, which later became American States/Safeco, in Fort Scott, for many years. Bob was a Systems Administrator, while Faye served as a Territory Underwriter. They were both volunteers for the Old Fort Genealogical Society, The Beacon, various church groups, and community Thanksgiving Dinners. Following retirement, they loved to travel in their RV, and then later with tour groups, they particularly liked the Branson area,

where they had made many friends over the years. They were almost always together, you rarely saw one without the other. In fact, Bob passed away on April 10th, 2017, barely more than two months following Faye's passing on February 7th.



Prior to passing on, being extremely generous and philanthropic, Bob and Faye planned for their sizeable estate to be gifted, via a Memorial Endowment, to seventeen different charitable organizations in the Bourbon County area. The Fort Scott Area Community Foundation was selected to manage these funds. Thanks to the pre-planning and generosity of Bob and Faye, these funds will continue to provide for our community in perpetuity.

The Fort Scott Area Community Foundation was established in 2007 and is a tremendous asset to Fort Scott and Bourbon County. The current and future principal in these funds will be in place forever; the interest will grow as the funds grow and will annually benefit the local area into the long-term future.
